



Terms & Conditions

The SIA Charity Run's "Early Bird" Lucky Draw (the "Lucky Draw") is open to selected individuals ("Participants"; each a "Participant") who have signed up for the SIA Charity Run 2017 within the Lucky Draw Period (as defined below).
